# THE NATIONAL HORSERACING AUTHORITY OF SOUTHERN AFRICA FEES AND CHARGES (including VAT)

#### 1. Fees and Charges General

- 1.1 The following fees and charges are published in terms of Rule 99.1 and are effective immediately, from the new racing year starting 1 August 2021 onwards.
- 1.2 Save as otherwise provided the fees quoted hereunder shall be paid by an applicant in respect of each year or portion thereof, ending 31 July following.

#### 2. Penalties

- 2.1 Where any re-application for a license or registration in terms of points 3, 4 and 5 below, is received in the office of the National Horseracing Authority in the racing district concerned
  - after 15 June, but on or before 31 July in any year, a surcharge of R150 shall be imposed and
  - if received after 31 July, but on or before 30 September of that year, a penalty of R300 shall be imposed.
