<b>ONCE THE TOTAL NUMBER OF CROP OFFENCES EXCEEDS NINE (9), THE FOLLOWING WILL APPLY:</b> * <b>AUTOMATIC</b> MINIMUM SUSPENSION OF 14 DAYS & R25 000 TO BE ADDED TO THE LAST PENALTY * <b>LISTED</b> and <b>GRADED RACES:</b> ADD 14 DAYS & 5% OF STAKE MONEY TO RESPECTIVE PENALTY IN GUIDELINE TABLE * <b>TWO (2) OFFENCES ON THE SAME DAY:</b> PROCEED TO THE NEXT PENALTY IN GUIDELINES * WORK RIDER RACES TO BE EXCLUDED AND ASSESSED IN ISOLATION						

Strikes with the crop will remain at twelve, however, the penalties in relation to contraventions of this Rule and Guideline will increase on **14 April 2023**, and that past contraventions from 1 September 2022, will be taken into account when considering penalties. This would be restored to zero on 1 August 2023.

Contraventions of Rule 58.10.2 (Guideline M) in listed and graded races would carry both monetary and riding suspensions and Riders with more than nine contraventions of this Rule and Guideline, since 1 September 2022, would incur a suspension from riding, over and above any other penalties, following a crop contravention of this nature.
