GENERAL NOTICE AMENDMENTS TO THE RULES

The National Board have in terms of Clause 16.2 of the Constitution, amended the following Rules, with effect from 5 August 2020.

The words that have a ~~strike through~~ them are to be deleted and the words in **bold** and underlined are to be added.

1.1.61 **(2) RACING CONTROL EXECUTIVE or RCE - the person appointed by the National Board to fulfil this function.**

6.1 LICENSED OFFICIALS

RCE

4.2.18 within their discretion to take such decisions and actions as they may deem necessary to ensure **the safety and/or wellbeing of PERSONS or HORSES involved in racing or** necessary to ensure the RACES are conducted in a manner which safeguards the interests of all individuals and PERSONS ~~present at the RACE COURSE~~. Such decisions will include the abandonment of a RACE/RACE MEETING, or any part thereof.

8.1.4 syndicate - in the name of the syndicate which shall comprise not less than 5 natural PERSONS and/or JURISTIC PERSONS and not more than ~~20~~ **100** natural PERSONS and/or JURISTIC PERSONS, **or such greater number as the CHIEF EXECUTIVE in his sole discretion may allow.**

8.3.5 Notwithstanding anything to the contrary contained in Rule 8.3, in the event of any Invitational International or Provincial Jockeys Challenge **or a Challenge pertaining to RIDERS from particular clubs, geographical areas, juristic entities or other distinguishing criteria**, being scheduled by any RACING OPERATOR, then it shall be permitted, in the sole discretion of the CHIEF EXECUTIVE ~~OPERATOR~~ and on such conditions as he determines, that the HORSES participating in the races relevant to that Invitational International Jockeys Challenge, run in colours depicting the country of birth or permanent residence of the rider of that HORSE, or, in the event of races relevant to that Invitational Provincial Jockeys Challenge, run in colours depicting the province of permanent residence of the rider of that HORSE. **In the event of HORSES participating in races relevant to a Challenge pertaining particular clubs, geographical areas, juristic entities or other distinguishing criteria, the HORSES shall run in colours depicting the clubs, geographical areas, juristic entities or the distinguishing criteria applicable.**

8.4 **In the event of the PERSON referred to herein, also being the TRAINER of the HORSES, then the representative shall, as soon as possible after his appointment, if it is decided to continue racing, place the HORSES under the care of a nominated TRAINER/S. During the period between the death of the PERSON and the nomination of an alternative TRAINER, the HORSES shall be placed under the care of:**

8.4.1 **the ASSISTANT TRAINER or STABLE EMPLOYEE, if any. In that instance, the provisions of RULE 10.1 will mutatis mutandis apply.**

8.4.2 **If there is no ASSISTANT TRAINER or STABLE EMPLOYEE, the HORSES will, with immediate effect no longer be eligible to race and will be placed under the care of a responsible person, or in the absence of such responsible person, in the care of a recognised horse care entity.**

10.5.4 shall notify the Chief Stipendiary Steward of the SB of the RACING DISTRICT within which the training establishment is situated, within ~~7~~ **2 business DAYS (excluding Saturday, Sunday and public holidays)** of the names of any HORSES which have entered or left his training establishment, such notification to be in the prescribed form;

10.5.5 shall notify the Chief Stipendiary Steward of the SB of the RACING DISTRICT within which the training establishment is situated of the death of any HORSE under his care within ~~7~~ **2 business DAYS (excluding Saturday, Sunday and public holidays)** of such death;

10.5.6 shall:-

10.5.6.1 within ~~7~~ **2 business DAYS (excluding Saturday, Sunday and public holidays)** of the event, give written notice to the Chief Stipendiary Steward of the SB in the RACING DISTRICT in which the HORSE is being trained when any HORSE under his care has been castrated or de-sexed;

10.5.6.3 ensure within ~~7~~ **2 business DAYS (excluding Saturday, Sunday and public holidays)** of a gelding entering his training establishment that the Chief Stipendiary Steward of the SB in the RACING DISTRICT in which the training establishment is situated, is notified that the HORSE is a gelding;

10.9 **No PERSON whose estate is or has been sequestrated and who has not been rehabilitated, shall be licensed as a TRAINER.**

10.10 **Any TRAINER whose estate is or has been sequestrated and who has not been rehabilitated, shall be disqualified and his license as a TRAINER shall be automatically terminated.**

- 44.4 A RACING OPERATOR shall not be required to re-apply for a licence annually. Such application should be made in writing at least 3 months before the current licence is to expire. The Application shall be considered by the NATIONAL BOARD as provided for in RULE 7.6. If the NATIONAL BOARD is of the view that a licence should not be granted or renewed, it shall afford the RACING OPERATOR a hearing before making a final decision on the matter. ~~and a licence granted to a RACING OPERATOR shall endure until it lapses or is cancelled in terms of RULE 44.2 or 44.5 or until the disbanding of the RACING OPERATOR.~~
 - 45.5 A licence in respect of a RACE COURSE shall be required to be renewed annually upon request from a RACING OPERATOR in respect of that RACE COURSE. Such application should be made in writing at least 3 months before the current licence is to expire. The Application shall be considered by the NATIONAL BOARD as provided for in RULE 7.6. If the NATIONAL BOARD is of the view that a licence should not be granted or renewed, it shall afford the RACING OPERATOR a hearing before making a final decision on the matter. ~~shall not lapse annually but shall remain in force until cancelled by the NATIONAL BOARD in its sole discretion or upon request by the RACING OPERATOR conducting RACE MEETINGS at such RACE COURSE.~~
 - 8. No PERSON shall enter, declare or start a HORSE for or in a RACE unless the OWNER is the current holder of COLOURS, save in the case of a HORSE entered or declared at the advertised closing time prior to 31 July for a RACE to take place on or after 1 August.

 - 50.1.1 shall declare or start a HORSE in a RACE unless the OWNER is a current holder of COLOURS, save as provided for in Rule 8.
 - 62.2.4 not ride a HORSE in a RACE in a careless, negligent, reckless or dangerous manner.
 - 62.2.11 Abuse, ill-treat or mishandle a HORSE either before, during or after the running of a RACE.
 - 72.1.14 use or be party to the use of directly or indirectly, or be in possession of any electric, electronic, mechanical or galvanic apparatus or equipment (whether in working condition or not), directly or indirectly, on or in relation to any HORSE, which may adversely impact or affect the welfare of the HORSE.
 - 77.1.1 to present himself on a RACE COURSE to take part in any RACE if at any time on the day of the RACE any sample of blood, breath or urine contains a BANNED SUBSTANCE, notwithstanding the fact that the RIDER made prior disclosure as provided for in RULE 77.3.

- 91.2 Pending the determination of an INQUIRY or any appeal arising from any INQUIRY in terms of the RULES, the NATIONAL BOARD, or in exceptional cases where in the opinion of the CHIEF EXECUTIVE or RACING CONTROL EXECUTIVE urgent intervention is required the CHIEF EXECUTIVE or RACING CONTROL EXECUTIVE, may impose such interim suspension or suspensions on any PERSON or in respect of any HORSE as they in their sole discretion deem fit.

7.9 REFUSAL AND CANCELLATION

In the event that an application for a PRIVILEGE is refused or a PRIVILEGE is cancelled in circumstances other than those relating to a warning off, no further application for the same PRIVILEGE shall be considered until 180 DAYS after such refusal or cancellation. Any application for a PRIVILEGE following a refusal or cancellation shall be regarded in all respects and for all purposes as a new application by the applicant for such PRIVILEGE. In the event of a PRIVILEGE being cancelled as a result of a life disqualification, such PERSON shall not be eligible to be granted any PRIVILEGE at any time in the future.

94. REMISSION

94.1 REQUEST FOR REMISSION

Notwithstanding the provision of any other RULE, anybody who has been warned off or disqualified or any PERSON who has been suspended may in WRITING request the NATIONAL BOARD to remit, in whole or in part, such warning off, disqualification or suspension. The NATIONAL BOARD may consider any such application and may, in its sole discretion, decide thereon. In the event that a request is refused, no further request shall be considered by the NATIONAL BOARD until expiry of a period determined by the NATIONAL BOARD. In the event of a life disqualification being imposed on any PERSON, all the restrictions relating to a warning off shall be applicable and in addition such PERSON shall not be eligible to be granted any PRIVILEGE at any time in the future.
